The purpose of this letter is to transmit the subject report in fulfillment of the Information Needs for Review of Postclosure Public Health and Environmental Standards—Letter Report (IM 20.06002.01.111.320). Your expectations for this report, sent to us on December 31, 2002, were very helpful for its preparation. Your request to include a review of the books by Edward Tufte on the display of quantitative information was received during the week of March 31, 2003. The books were reviewed and specific guiding principles on the construction of graphs, charts, and tables were identified and referenced in the report. The graphics contained in the report were refined based on Tufte's guiding principles to the extent that they were clearly beneficial. Throughout the report the authors emphasize that the quantitative information needs that they have outlined and the suggested method used to display the information are not regulatory requirements. However, the authors do suggest that following the guidance provided in the report will improve the efficiency, accuracy, and thoroughness of a reviewer's job. In addition, the report clearly states in several locations that the graphics are only examples and are not illustrative of the expected performance of the proposed repository.


