This Modification No. 3 to Task Order 15 de-obligates funds in the amount of \$100,000.00, thereby decreasing the obligated amount from \$300,000.00 to \$200,000.00.

The period of performance for Task Order 15 is extended through October 31, 2004, in accordance with ATL's May 2, 2002, proposal and revised spending plan. This extension does not effect the total cost ceiling, \$788,175.00, of which \$729,792.00 represents the reimbursable costs and the sum \$58,383 represents the fixed fee.
