\$1,318.60 in funding are hereby allotted to this task order. Accounting Data for Task Order No. 2 is as follows:



STATEMENT OF WORK:

The work required is to perform a position classification review, in accordance with NRC position evaluation procedures, of a position currently classified as a Fire Protection Engineer, GG-14, in the Office of Nuclear Reactor Regulation, Fire Protection Engineering and Special Projects Section. Staff of the NRC's Office of Human Resources (OHR) have recently evaluated the position, and the incumbent has appealed that decision.

The contractor will review necessary documentation related to the position, and will meet with OHR staff, the incumbent, and the incumbent's supervisory chain, as deemed necessary to gain a full understanding of the requirements of the position. The contractor shall submit a recommendation to the NRC PO in the form of a written review report concerning the proper grade of the position in question by the end of the tenth calendar day after the NRC grants the contractor NRC building access.

The contractor personnel assigned to this task should be fully qualified classification and position evaluation specialist(s) with experience in performing position evaluation reviews and analyses for Federal engineering positions at higher grade levels. The contractor will not have access to any NRC databases or other electronic information.
