Reference: Notice of Opportunity to Comment on Model Safety Evaluation on Technical Specification Improvement Regarding Extension of Reactor Coolant Pump Motor Flywheel Examination for Westinghouse Plants Using the Consolidated Line Item Improvement Process (68 FR 37590 June 24, 2003)

In response to the Federal Register Notice (FRN) referenced above, the Westinghouse Owners Group (WOG) would like to clarify the applicability of WCAP-15666-NP, Rev. 0, "Extension of Reactor Coolant Pump Motor Flywheel Examination" to Babcock & Wilcox (B&W) Nuclear Steam Supply System (NSSS) plants.

WCAP-15666-NP, Rev. 0 is applicable to B&W NSSS plants provided that the licensees for the B&W NSSS plants identified in Table 2-3 of the WCAP confirm the applicability of the WCAP to their plants. As such, the "Background" and "Applicability" sections of the FRN referenced above should be modified to include the B&W NSSS plants that are identified in Table 2-3 of WCAP- 15666-NP, Rev. 0.

The licensees for Three Mile Island 1 and Crystal River 3 have confirmed that WCAP-15666-NP, Rev. 0 is applicable to these plants.
