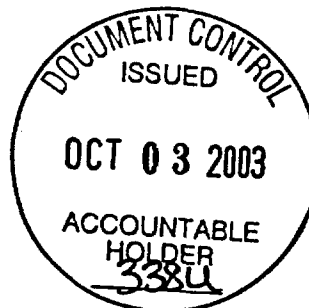


Oil Spill Reportability (SOS 96-0890)

1. An oil sheen is caused on waters of the State of Missouri
2. Greater than 50 gallons is spilled and any portion of the spill leaves UE property.
