
Dear Mr. Rathbun,



Dear Louise:

In a conversation over the weekend I learned that nuclear power plants, according to NRC rules, must have two back-up power sources in the event of a power blackout, such as the one we recently experienced in the Northeast.

I was told that at the present time, Ginna has only one source of emergency power. Since I am opposed to the renewal of their agreement with the NRC, I would think that this may be one more reason to oppose the sale of this out-moded, over-age plant. If your office has any information about this, I would appreciate hearing from you about this although I fear it may be too late to change a decision which may have already gone forward.
