There are new updates to the fire protection web page which are listed below.

1. NEW FEATURE NRC TRIENNIAL FIRE PROTECTION INSPECTIONS This item has been added as a result of comments received from regional inspectors. It is a table, put together by Gerry Wiseman on his personal time, which lists inspection findings, URI's, and CAP items from RI, RII, RIII, and RIV triennial FP inspections. For each region, the plants are listed, along with the inspection report ADAMS accession #, and a summary of the findings (white, green, yellow).

In addition, if you click on the accession number, it will take you directly to the inspection report, which is in Word Perfect format. This way, you don't have to retrieve the report from ADAMS. As I receive updates from Gerry, I will make updates to this table. This table can be found at the following link:

Please note that this table is not a searchable database. As we discussed, Hollis Turner from RII is currently working with the regions and headquarters to modify the RPS database so that you can easily search for FP inspection findings, etc. In the meantime, Gerry was kind enough to provide this to everyone as a useful reference.
