Dear Ms. Maryland:

This is to confirm that we have 01 (one) Gamma source housing M/N: 7062B, S/N:S96F1212 and 01 (one) Kay Ray Continuous Level Detector M/N: 70022C-1, S/N: D96G2611 ( Level Control-LC) that came with the used process equipment we purchased from Nu-Kote in 1999. We then modified/upgraded the whole system, level control was replaced with load cells weight control, and have been keeping the LC in spare parts cabinet sin then for possible future usage.

After 9/11, we were contacted by NRC and were advised to contact TN Technologies-Kay-Ray Sensall in Texas for a proper disposal if we decided not to use the LC. We did have a quote from TN, which was submitted to our plant manager for approval.

We haven't got approval from upper management yet. The device is still kept in locked cabinet.

Hope this response is of some help in your effort to locate the gauges.

Please check your files and see if your company has receive two gauges (Kay-Ray Sensall Model 7062B, Serial Nos S96F1211 and S96F1212) from one of NRC licensees (Nu-Kote in Derry, PA). The radioactive material gauges were apparently transferred in late 1997 or early 1998.
