
SUBJECT: Report of Full Compliance with the Order for Compensatory Measures Related to Fitness-for-Duty Enhancements Applicable to Nuclear Facility Security Force Personnel

References 3 and 5 detailed Omaha Public Power District's (OPPD's) responses to the requirements of Reference 2 for Fort Calhoun Station Unit No. 1 (FCS). Reference 2 requires that implementation of the compensatory measures (CM) shall be completed no later than October 29, 2003. Reference 2 also states that Licensees shall report when they have achieved full compliance with the requirements of Reference 2. As of October 29, 2003, OPPD has

achieved full compliance with the requirements of Reference 2 as modified by Reference 6 at FCS.
