This letter provides supplemental information requested in a teleconference held between PPL and NRC on October 22, 2003. This supplemental information was requested to support NRC's review of the PPL Susquehanna LLC decommissioning report of financial assurance submitted on March 21, 2003 [Reference 1].

During the teleconference, NRC requested PPL to provide additional information related to the SAFSTOR decommissioning option referenced in the Susquehanna NRC Decommissioning Funding Status Report of December 31, 2002.

The SAFSTOR decommissioning option was developed as part of a Susquehanna Site-Specific Decommissioning Cost Analysis and assumes site license termination 60 years after permanent cessation of operation of Unit 1. After final shutdown of Unit 1, the sequence of events leading to termination of the 10 CFR Part 50 license is assumed to be as follows:


- 1.5 year transition into decommissioning and preparation for safe storage
- 52 year period of dormancy
- 1.5 year period of site reactivation and preparation for decommissioning
- 5 year period of decontamination and dismantlement culminating in license termination.

These durations are rounded slightly and are for Unit 1. The Unit 2 durations are slightly less in some cases because of the later expected shutdown (about 20 months after Unit 1). However, license termination for both units still occurs 60 years after Unit 1 shutdown.
