Judge Rosenthal has just learned that, in a September 30, 2003, status letter to Judges Bechhoefer and Baratta in connection with the Sequoyah MLA-4 proceeding, NRC Staff counsel Giovanna M. Longo represented that SFC and the State of Oklahoma are "continuing negotiations concerning the reclamation plan." He assumes that the reference was to the plan that is the subject of the hearing requests in MLA-6. If so, he would appreciate it if counsel for both SFC and Oklahoma would advise him and Judge Baratta, in a memorandum to be filed and served no later than Wednesday, December 3, 2003, of their understanding of the current status of those negotiations.
