Dear Mr. Zimmerman;

The enhanced security mandates for nuclear power plant operators include, in many instances, the need for suitable waterway barrier systems. While we realize the NRC neither recommends nor specifies products or solutions, we do suspect you keep abreast of market availabilities.

The purpose of this letter is to introduce you to Worthington Products and to ask how we go about receiving the necessary security clearance to know what the specific security mandates are for waterway security.

By way of introduction, Worthington Products, Inc. provides a full range of waterway security barriers ranging from simple line of demarcation systems to full systems designed to stop a 35' boat traveling at a high rate of speed. I've enclosed a general flyer overviewing our waterway security solutions. In this respect, I will phone you to enquire how we can get the required clearance. In the meantime, kindly let me know if you have any comments or questions.
