The purpose of this modification is to obligate FY'04 funds in the amount of \$16,886.00, thereby increasing the obligation amount from \$780,000.00 to \$796,886.00, thus fully funding the contract.

Accordingly, the following changes are hereby made:

Under Subsection B.2 - CONSIDERATION AND OBLIGATION - COST PLUS FIXED FEE, Paragraphs c and d are deleted in their entirety and substituted in lieu thereof the following:

- "(c) The amount currently obligated by the Government with respect to this contract is \$796,886.00, of which the sum of \$737,516.00 represents the estimated reimbursable costs, and of which \$59,370.00 represents the fixed fee.
- (d) It is estimated that the amount currently allotted will cover performance through November 19, 2003."
