On January 27, 2003, Exelon Generation Company, LLC (Exelon), licensee for Braidwood Station, Units 1 and 2, Byron Station, Units 1 and 2, Dresden Nuclear Power Station, Units 2 and 3, LaSalle County Station, Units 1 and 2, Limerick Generating Station, Units 1 and 2, Peach Bottom Atomic Power Station, Units 2 and 3, and Quad Cities Nuclear Power Station, Units 1 and 2, submitted its written response to the Order. On March 18, 2003, the NRC staff initiated a conference call with the licensee to discuss the response to the Order. On March 26 and May 6, 2003, the licensee issued letters clarifying its January 27, 2003, response to the Order.

The NRC staff has completed its review of your responses. Based on that review, the NRC staff finds that your responses to the January 7, 2003, Order are acceptable and responsive to the Order.
