The purpose of this modification is to provide incremental funding in the amount of \$106,113.32 thereby increasing the obligated amount of the subject contract from \$273,512.33 to \$379,625.65.

Accordingly, the following change is hereby made:

Under Paragraph B.2 - CONSIDERATION AND OBLIGATION, the first sentence of Subparagraph (b) is hereby deleted in its entirety and substituted in lieu thereof the following:

"(b) The amount presently obligated with respect to this contract is \$379,625.65."
