

The purpose of this modification is to increase the amount funded in the delivery order by \$138,200.00, from \$1,910,213.45 to \$2,048,413.45. Accordingly, the contract is hereby modified:

"The amount presently obligated with respect to this order is \$2,048,413.45."

2. Section D.10, Consideration and Obligation, third paragraph, as modified in Modification No. 2, is deleted in its entirety and substituted with the following in lieu thereof:

"It is estimated the amount currently allotted will cover performance of the effort through June 30, 2004."
