Dear Administrative Judges:

Your October 29, 2003 Memorandum and Order (LBP-03-20, 58 NRC\_\_\_\_) gave the NRC Staff ("Staff") until November 28, 2003 to transmit the Hearing File in this case. The "NRC Staff Motion for Modification of LBP-03-20 with Respect to Directions Regarding Hearing File" (November 5, 2003), at 1, requested that you modify LBP-03-20 "...to provide that the Hearing File will be created and maintained by a readily accessible list of the documents, with their Agencywide Documents Access and Management System ("ADAMS") accession numbers, dates, and titles." By letter dated November 14, 2003, the Staff transmitted its initial compilation of documents for the Hearing File, using the ADAMS accession numbers as the means by which the Presiding Officer, Special Assistant, and parties would access those documents they needed. That list covered licensing documents from the creation of the docket through October 8, 2003. Attached is an update to the Hearing File, in a similar format, covering the period October 8, 2003 through November 18, 2003.

The Staff considers these two documents to meet the requirements of LBP-03-20 as to the creation and maintenance of the Hearing File, assuming you grant the Staff's November 5, 2003 motion. The Staff wishes to be certain as to the status of its compliance. Accordingly, the Staff respectfully requests that you advise it whether the Staff also has to create and maintain a "paper" Hearing File while its motion is being considered.
