By letter dated January 7, 2003, the Nuclear Regulatory Commission (NRC) transmitted to PPL Susquehanna, LLC (PPL) an Order containing compensatory measures related to access authorization [Reference 1].

In a letter dated January 23, 2003, PPL committed to revise all applicable procedures and complete all necessary actions to include the provisions of all compensatory measures except B.1.1, C.1.6 and C.1.8 by July 7, 2003 [Reference 2]. PPL provided notification by letter dated April 3, 2003 that PPL was in compliance with B.1.1 [Reference 3].

In a letter dated July 3, 2003 [Reference 4], PPL notified the NRC all applicable procedures were revised and all necessary actions were completed to be in full compliance with all Compensatory Measures stated in Reference 1, except for C.1.6 and C.1.8 which were required to be implemented by January 7, 2004.


The purpose of this letter is to report to the NRC that PPL has achieved full compliance with all the compensatory measures related to access authorization.
