1 them in the Motion (including the Memorandum of Points and Authorities accompanying the
2 Motion).

3 The Court having determined that adequate notice of the Motion was given to
4 parties in interest as appropriate under the circumstances, and the Court having considered
5 the various pleadings, declaration and any other materials filed in support of the Motion and
6 the statements of counsel appearing at the hearing on the Motion, and the Court having
7 received no opposition to the Motion, and good cause appearing therefor,

8 IT IS HEREBY ORDERED that:

9 1. The Motion is granted; and

10 2. Pursuant to Section 363 of the Bankruptcy Code (11 U.S.C. §363), the
11 Debtor is authorized to implement the Diablo Canyon Power Plant Steam Generator
12 Replacement Projects requiring contractual commitments and multi-year capital
13 expenditures in an amount not to exceed \$706 million, all as more particularly described in
14 the Motion.
