[ The following is an amendment to the 02 license for control of the pole building. ]

### POLE BUILDING CONTROL PLAN

#### Pole Building Area Designations

Inside the pole building are three discrete areas after leaving the entrance area on the northwest end of the building. They are the area where the waste is stored (Area 1), the area beyond the barrier rope but outside of the processing area (Area 2) and the processing area (Area 3).

#### Contamination Control

Safety Light Corporation (SLC) will do wipe surveys on the floor of the pole building once every six months for Areas 1 and 2. SLC does not intend to enter Area 3 and therefore a survey will not be done. If for any reason in the future there is a need to go in that room a program will have to be put together to determine airborne levels if any before entering the Area and testing for removable contamination.

**Controlling Access**

All access ways will remain locked at all times. The Radiation Safety Officer will control keys. Access will only be allowed through permission of the RSO or his designate.

**Surveys for External Radiation**

Surveys for external radiation will be performed at periodic intervals at the discretion of the RSO or his designate. The radiation area will be maintained based on these surveys.

**Contracted Services**

If approved radiation contractors are performing work in the building, the responsibility for the above will be primarily theirs.

We had also discussed the sealing up of the top ends of the pole building. A rad contractor quoted us \$7,500 to do the job. The high level of radiation precludes us from hiring a general contractor from the area. Safety Light Corporation will need funds from the escrow account to accomplish the above.
