To those concerned:

We transmit herewith the written comments of the Confederated Tribes and Bands of the Yakima Indian Nation ("Yakima Nation"). The Yakima Nation is an affected tribe as regards to the Reference Repository Location, Hanford Site, Washington. This transmittal within the announced date of the 20th of March, 1985, is not in waiver of our contention that the limited time in which to comment is a violation of the Nuclear Waste Policy Act ("NWPA"). The Department's limitation and also scheduling public hearings before adequate time to study the Draft Environmental Assessments ("DEA") seeks to make public participation and consultation and cooperation provisions of the NWPA a sham. We submitted adequate justification requesting a longer period and we are sure that the administrative record from the Project Office could do naught but support our reasonable requests. Affected states and other affected tribes have likewise made similar reasonable requests.


We likewise call to your attention and again record our contention that the restriction on our grants against the study of defense and existing nuclear activities at the Hanford Reservation is a violation of the consultation and cooperation provisions of the NWPA. This also has limited our ability to fulfill our responsibility under the NWPA.


