Text Of Telecon

Kristine Westbrook returned my call placed in order to clarify a March Geology Briefing agenda item. This agenda item, pertaining to USGS support of the BWIP, was mentioned by NRC during a conference call between DOE/BWIP/NRC personnel held the previous day. Kristine said that the USGS support referred to a discussion of the regional geologic mapping effort. I told her we would be able to incorporate this discussion in the Tectonics portion of the briefing. I also discussed with her the overall intent of the presentations to be held the first day of the briefing; i.e., these presentations were intended to provide the NRC staff with an overview and also to serve as a vehicle by which NRC could identify items they would like to discuss in more detail the following day. Specialized staff members would be available the second day to carry out such discussions. She said she would discuss our conversation with Phil Justus in order to be sure that expectations were clarified.
