

NOTES ON DISCUSSIONS AMONG DOE, NRC STAFF (R. E. BROWNING, F. R. COOK AND R. J. WRIGHT) AND ROCKWELL MANAGEMENT PERSONNEL ON AUGUST 11 AND 12, 1983

The purpose of the discussions was to introduce F. Robert Cook, the NRC BWIP Site Representative, to various DOE and Rockwell management and to brief these management on the role of the Representative in the future. DOE management included A. G. Fremling, R. P. Fasulo, J. H. Anttonen, and O. L. Olson. Rockwell management included D. J. Cockeram.

The following observations and commitments were made:

1. Anttonen reviewed a draft position description identifying functions and responsibilities for the Representative to ensure mutual understanding.
2. Anttonen and Browning agreed it is desirable for the NRC Representative to listen to DOE and Rockwell discussions concerning BWIP activities in order to stay informed on planning and new issues as well as actions to resolve issues. DOE agreed to inform the Representative of such discussions in advance.
3. Browning noted that the Representative's major duty was to interface with DOE and its contractors and not the States and Indian Tribes. The point of contact with States and Indians would continue to be at Headquarters. Browning also noted that it is intended that NRC interaction with the public and media concerning the BWIP would continue to be through Headquarters and not the Representative.
4. DOE and NRC management agreed that the NRC BWIP project at NRC Headquarters would prepare by August 31, 1983, draft project specific agreements concerning areas of interaction involving the BWIP. This is to implement actions outlined in the NRC/DOE Procedural Agreement of June 27, 1983, identifying guiding principles for interface during site investigations and site characterization.
5. The NRC staff and DOE management discussed the interactions of the Representative with DOE contractors. It was agreed that it was an objective of the Representative to facilitate information exchanges and not to suggest directions for DOE contractor actions, this being the role of DOE Contract Management.
