On July 19-20, 1983, DOE/NPO and ONWI staff members working on the Salt Repository Project met with members of the NRC staff and representatives of Utah, Texas, Louisiana, and Mississippi to discuss DOE's plans for a system of information management and transfer.

A July 19, 1983 letter from J. Neff (DOE/NPO) to H. Miller (NRC) DOE/NPO has transmitted descriptions of this system along with a request for NRC's suggestions and opinions on a system that would be of most benefit to NRC. Clearly, the system plans are in a formative stage.

Therefore, this request presents an opportunity for the NRC staff to contribute to the development of the DOE information management and transfer systems which would support all interested parties during both the prelicensing and licensing stages for all three DOE projects. It also presents the opportunity to further formulate what NRC's information management system should be considering, the direction DOE's system will take and the potential for linking to that system.

The response to DOE/NPO is being coordinated by R. Johnson. To begin developing the response a meeting will be held on Tuesday, August 2, 1983 (see attached agenda). The purpose of this meeting is to describe the system, answer questions concerning DOE/NPO plans, exchange ideas on the principle requirements for such a system both in the short-term (pre-licensing) and long-term (licensing), discuss the present use of information management systems (data bases) for similar projects, and obtain input on key topics or questions to focus NRC's review and
