May 23, 1984 Meeting Summary with NRC

Meeting Purpose: To ascertain whether it would be useful to get a copy of the security plans from spent fuel storage facilities for Fluor to fulfill their SOW obligations to DOE concerning repository conceptual design.

In the morning we discussed the range of security required at different types of facilities. As a result it became apparent that at this time the GE Morris Illinois spent fuel facility was the most applicable representative of a NRC licensed facility and that the NFS West Valley facility was the most applicable DOE facility.

In the afternoon we had an opportunity to view the GE Morris physical security plan, the DOE West Valley facility plan, as well as the VEPCO Surry security plan and training manual which is under review for licensing.

As a result of the meeting and review of the plans DOE intends to ask the licensee (GE Morris Illinois) for a copy of the security plan for Fluor and to locate the appropriate DOE contact to ask for a copy of the West Valley security plan. The contact leads NRC supplied us are:
