Thank you for your June 13, 1985 letter inviting Mississippi officials to meet with NRC staff to discuss the Project Decision Schedule (PDS) required under Section 114(e) of the Nuclear Waste Policy Act. We would like very much to review with you the PDS proposal by the Department of Energy, and hereby accept your offer.

I recommend a meeting in Washington on a date mutually agreeable to NRC staff and those who will represent the State of Mississippi. At this time, I expect those persons to be myself, John Green and Ron Forsythe from the Energy and Transportation Board, and Mack Cameron from the Office of the Attorney General.
