SUBJECT <u>INVITATION TO MONITOR A DECISION-MAKING MEETING - SEISMIC SURVEYING</u>					
SUMMARY <p>Jim Mecca (with Dave Dahlem &amp; Ann Tallman present) invited NRC (suggested Bakr Ibrahim aka/ Ed Levine of WGC) to monitor a meeting in Austin or Houston, TX on July 26, 1985 between DOE-RHO and its contractors/advisors on seismic surveying program at BWIP. This invitation is a direct follow-up to the meeting in Silver Spring in May between NRC &amp; DOE on their impending (now partially completed) seismic surveying testing; DOE is providing an opportunity for NRC geophysicists to be kept informed of the results to date of the testing (using various seismic sources and geophone arrays) and of the bases for decisions to be made by DOE on the "production" phases of the seismic work. NRC can comment at the meeting. This event is not being developed as a full-fledged meeting or workshop or data review. No material can be provided to NRC in advance of 7/26 for DOE contractual reasons.</p>
