SUBJECT: PARTICIPATION BY JEFF KIMBALL IN THE REVIEW OF
THE BWIP SCR

This letter confirms the conversation between yourself and Dr. Philip Justus concerning Jeff Kimball's limited participation in the review of the BWIP SCR scheduled to begin November 15, 1982.

It is anticipated that Jeff Kimball will review relevant parts of Chapter 3, "Geologic Description of the Reference Repository Location" and Chapters 13 and 14 (site and design issues and plans). He should pay particular attention to sections of the report that: 1) refer to the WNP-2 SER and SSER and 2) may impact the three topic reports on seismic issues at BWIP that Mr. Kimball has written. In addition, he will review the NRC issue analysis on seismic hazard at BWIP.

It is suggested that the deliverables, due November 29, consist of notes, in the margin of the SCR text, and the NRC issue analysis of his specific comments, and mark-ups of his three topic reports if any revision is necessary.

The geologic stability team has scheduled a meeting at 10:00 A.M. on Monday, November 15 in room 440 to discuss details of the SCR review. It would be appreciated if Jeff Kimball could attend this meeting.
