This is to advise you of an arrangement, now in effect, for obtaining information about significant parts of the SCR that appear to be ambiguous, inconsistent, or otherwise confusing. DOE has indicated that it wishes to cooperate with us in avoiding any possible misunderstandings about the meaning of the SCR material. Thus, we have agreed on a scheme for questions by NRC and answers by DOE, with quick turn-around.

Following are the principles of this scheme.

- (1) The questions are limited to matters of clarification and are not requests for additional information.
- (2) Questions and answers will be transmitted by telephone, for expediency, with a written follow-up (telefax or mail) for the record.
- (3) DOE's contact is David Squires, Richland. NRC's contact is myself, with Paul Prestholt as an alternate when I am unavailable. No other contacts should be used by NRC, or its consultants and contractors, without prior approval by me.
- (4) Squires and I will aim toward one telephone interaction per day, now set at 9:30 a.m., EST.

All questions will need to be submitted in written form, expressed clearly and concisely. To avoid unnecessary steps in copying, I request that the questions be prepared in the form of the attachment. Typed material is preferred, but legible, handwritten material is acceptable if time is short.
