
Subject: Fitness for Duty Performance Data Reports - Second Period - 2003

During the current reporting period, i.e., July-December, 2003, twenty-four (24) specimens from all locations were reported as presumptive positive for cocaine as a result of on-site screening. All twenty-four (24) of the specimens were confirmed as positive by the laboratories and were verified as positive by the Medical Review Officers for a confirmation rate of 100%.

BRAIDWOOD STATION

Management Actions and Sanctions

Nine (9) positive tests resulted in the denial or revocation of unescorted access. One (1) short-term contractor was denied access after providing a substituted or adulterated test specimen.

Events Reported

There were no 24-hour reportable events during this reporting period.

BYRON STATION

Management Actions and Sanctions

Thirteen (13) positive tests resulted in the denial or revocation of unescorted access.

Events Reported

There were no 24-hour reportable events during this reporting period.

CLINTON POWER STATION

Management Actions and Sanctions

Three (3) positive tests and one (1) refusal to test resulted in the denial or revocation of unescorted access.

The initial cutoff level for marijuana is 50 ng/ml for all individuals except for licensee bargaining unit personnel whose initial cutoff level for marijuana is 100 ng/ml.

There were no 24-hour reportable events during this reporting period.

DRESDEN NUCLEAR POWER STATION

Management Actions and Sanctions

Ten (10) positive tests and one (1) refusal to test resulted in the denial or revocation of unescorted access. One (1) short-term contractor was denied unescorted access after providing a substituted or adulterated test specimen.

Events Reported

There were no 24-hour reportable events during this reporting period.

LASALLE COUNTY STATION

Management Actions and Sanctions

Five (5) positive tests resulted in the denial or revocation of unescorted access.

PEACH BOTTOM ATOMIC POWER STATION

Management Actions and Sanctions

Seventeen (17) positive tests and one (1) refusal to test resulted in the denial or revocation of unescorted access.

Events Reported

On November 25, 2003, a follow-up test of a contract supervisor was verified as positive by the Medical Review Officer. The individual's unescorted access was revoked and a work performance investigation was completed. A 24-hour reportable event notification was made to the NRC Operations Center in accordance with 10 CFR 26.73(a)(2).

QUAD CITIES NUCLEAR POWER STATION

Management Actions and Sanctions

Three (3) positive tests and one (1) refusal to test resulted in the denial or revocation of unescorted access.
