
In regards to the application by Louisiana Energy Services (LES) to build and operate a Uranium Enrichment Plant in Lea County, New Mexico, the Board of Directors of the Jal Chamber of Commerce would like to offer our utmost support.

Jal is located approximately 25 miles south of the proposed facility, in southern Lea County. Our economy has relied on the energy industry throughout most of our history. Many years of oil and gas production have acquainted us with the hazards and benefits that go hand-in-hand with any type of energy production. We have no doubt that this facility will be operated in a safe and efficient manner that will be beneficial to the people of Lea County, and in the best interests of our national energy needs.
