Enclosed you will find drafts of regulatory requirement topic no.'s E17 ("Adverse Condition--Geochemical Processes") and E36 ("Structures, Systems, and Components Important to Safety--Protection Against Natural Phenomena and Environmental Conditions"). I am transmitting them to you for the purpose of performing a "compliance review" in accordance with the review instructions contained in the Review Plan for Preliminary Program Architecture E Milestones (dated December 7, 1988). As stated in the review plan (page 3, item 4), the "compliance review" will precede the "technical review," and will help to establish whether the draft regulatory requirement topics are of sufficient development to merit "technical review" by NRC staff. The review plan also indicates that an "elements of proof review" (page 4, item 3) will be performed at this time by the Office of the General Counsel.

We wish to conduct a brief kick-off meeting on Monday, December 12, 1988 from 2 p.m. to 3 p.m. in room 4-B-13. At this time we will briefly discuss the requirements of the "compliance review" and, as stated in the review plan itself, conduct a brief overview of Technical Operating Procedure (TOP)-001-02, Program Architecture Relational Database Work Instruction that will be used to perform the "compliance" and "technical reviews."
