During the conference call, staff discussed Requests for Additional Information (RAIs) in the areas of the Integrated Safety Analysis and criticality with Louisiana Energy Services (LES) personnel.

The four RAI questions discussed were:

1. ISA-42

LES staff asked for clarification on a reference in ISA-42 to ISA-1. Staff indicated that it would check the reference to see if it referred to the correct RAI.

2. ISA-43

LES staff asked for clarification regarding the statement in ISA-43 that references "IROFS25, IROFS27, and eight other NCS IROFS." LES indicated that it appears that "eight other NCS IROFS" should be "seven other NCS IROFS." Staff indicated that it would recount the applicable IROFS.

3. ISA-50

This question refers to the Initiating Event Frequency (IEF) for NCS accident sequences. It appears that the information in the license application (ISA Summary text and the tables) does not clearly indicate how LES determined the IEFs.

In the conference call, LES stated that it used the approach discussed at the February 26, 2004, meeting with staff. In this approach, LES first determined the frequency of the initiating event and followed the progression through the event scenario. LES did not determine initiating event frequencies based on the frequency of the scenario consequences. LES indicated that it would review the tables cited in ISA-50 and clarify its IEF approach.

4. ISA-62

This question refers to the technical basis for demonstrating that Administrative Control IROFS will meet the performance requirements of 10 CFR 70.61. LES staff indicated that it did not understand what is needed to respond to the question. Staff indicated that it would check with the reviewer of this RAI and clarify what is needed.
