5. The Government hereby exercises Optional Task 14, Document Backlog Processing and Optional Task 15, Electronic Hearing Docket (EHD) Document Processing Support Services. Services shall be billed at the rates specified for the base period of the contract.

The following is a summary of obligations from the date of award through the date of this action:

FY 2003 OBLIGATIONS: \$1,114,731.66  
FY 2004 OBLIGATIONS: \$2,154,000.00

CUMULATIVE TOTAL OBLIGATIONS: \$3,268,731.66

All other terms and conditions of the subject delivery order remain unchanged.

The purpose of this modification is to: 1) Increase the ceiling amount in the contract, by \$77,746.87, from \$5,460,834.66 to \$5,538,581.53; 2) Increase the funding amount in the contract by \$1,766,000.00 from \$1,502,731.66 to \$3,268,731.66; 3) Reduce the level of effort under Task 12, Center for Nuclear Waste Regulatory Analysis (CNWRA) Document Processing Support Services, thereby decreasing the total estimated amount for Task 12 by \$82,620.28 from \$119,564.56 to \$36,944.28; 4) Increase the level of effort under Task 17, ADAMS Retrofit of High Level-Waste Paper Documents, thereby increasing the total estimated amount for Task 17 by \$160,367.15 from \$220,115.04 to \$380,482.19; 5) Exercise Optional Task 14, Document Backlog Processing; and 6) Exercise Optional Task 15, Electronic Hearing Docket (EHD) Document Processing Support Services. Accordingly, the contract is hereby modified:

- Optional Form 347, under Item 17. Schedule, second paragraph, as modified in Modification No. 1, is deleted in its entirety and substituted with the following in lieu thereof:

"The total estimated ceiling amount of this delivery order for the services ordered, delivered, and accepted under this order is \$5,538,581.53."

- Optional Form 347, under Item 17. Schedule, third paragraph, first sentence, as modified in Modification No. 4, is deleted in its entirety and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this order is \$3,268,731.66."
