Dear Mr. Wood:

This is in reference to a letter dated May 14, 2004, from Mr. Russell Stein of your staff, requesting that your staff be authorized to open the plenum for inspection, and unload sources and reposition sources/source holders in the plenum. The letter also stated that your staff has received formal training and certification from REVISS on cask handling and source loading.

We need the following additional information in order to complete our review of your request:

1. Names of the individuals who will perform the requested activities;
2. Documentation of each individual's education, radiation safety training, and experience of handling the radioactive material;
3. Copies of the certifications that are described in the above referenced letter;
3. For each individual, documentation of his/her prior experience of performing these activities. The documentation must include the name of the facility (including its NRC or an Agreement State license number), dates, types of activities performed, and the name(s) of the authorized user(s) under whose supervision these activities were performed; and
4. Procedures for transferring casks from transport vehicles to the irradiator room.

Please be reminded that your Nuclear Regulatory Commission License No. 37-30804-02 requires that loading/unloading/repositioning of the sources be performed by persons who are specifically authorized by the NRC or an Agreement State to perform these operations. These operations must continue to be performed by such individuals until you have received amendment to your license authorizing other individuals to perform such operations.
