Dear Mr. Wood:

This is in reference to your letter dated May 25, 2004, and a subsequent facsimile dated June 1, 2004, from Mr. Russell Stein of your staff. The information contained in these communications does not fully provide the information requested in my letter dated May 20, 2004. In order to continue our review, we need the following additional information:

1. The training certificates from REVISS Services, Ltd., indicate that the individuals have received training in handling of the casks. In addition to these certifications, we also need certifications (for each of these individuals) confirming that each has received specific training in handling of the sources (removing the sources from the casks, and loading them in the plenum of the irradiator), **and** each can perform these tasks without the supervision of another authorized user.
2. Our records that indicate that Mr. Russell Stein was a Radiation Safety Officer of Precision Materials Corporation. However, we do not have records that indicate that he received training in source loading/unloading procedures, or that he was authorized by the NRC or any Agreement State to perform these activities. Please provide documentation of his training to perform these tasks **and** the name(s) of the authorized individual(s) under whose supervision he performed these tasks.

We will continue our review upon receipt of this information. Please reply to my attention at the Region I Office and refer to Mail Control No. 135003. If you have any technical questions regarding this deficiency letter, please call me at (610) 337-5364. If we do not receive a reply from you within 30 calendar days from the date of this letter, we shall assume that you do not wish to pursue your application.
