Dear Mr. Wood:

This is in reference to your letter dated June 28, 2004, in response to our letter dated June 9, 2004.

Please note that NRC policy requires that in order for an individual to be authorized to perform specific tasks involving licensed material, the individual must have received appropriate radiation safety training **and** must have acquired adequate experience of performing the tasks under the supervision of an individual, who himself/herself was authorized to perform such tasks.

You stated that the three individuals have read and have been tutored by REVISS on the subject of unpacking and use of cobalt 60 sources. You also stated that Gray\*Star, Inc., provided hands on training for the handling of the sources. Please note that theoretical knowledge of procedures is necessary but not sufficient for an individual to be authorized to perform the procedures (using radioactive sources) independently without the supervision of an authorized user.

In order for us to authorize the individuals to perform the requested tasks, you must provide documentation (a certification from an authorized user) that demonstrates explicitly that each of the individuals has had hands-on experience of loading and unloading the cobalt 60 sources under the supervision of an authorized user, **and** the individual is capable of performing these tasks independently without the supervision of an authorized user.

In accordance with 10 CFR 2.390, a copy of this letter will be placed in the NRC Public Document Room and will be accessible from the NRC Web site at <http://www.nrc.gov/reading-rm.html>.

We will continue our review upon receipt of this information. Please reply to my attention at the Region I Office and refer to Mail Control No. 135003. If you have any technical questions regarding this deficiency letter, please call me at (610) 337-5364.
