(Scheduling Possible Telephonic Argument On Hearing Request)

This proceeding concerns a request for hearing submitted on August 30, 2004, by the Pennsylvania Department of Environmental Protection (Pennsylvania) in response to a June 23, 2004 notice of opportunity for hearing regarding a proposed amendment to the 10 C.F.R. Part 30 byproduct materials licenses of the Safety Light Corporation. The notice was published in the Federal Register on June 30, 2004 (69 Fed. Reg. 39,515).



The Board will determine whether argument is necessary after reviewing all of the participants' submissions, and it will notify the participants of such determination during the week of October 11, 2004. In the event the Board decides to hold argument, it will provide the

participants with additional information regarding how the telephonic argument will be conducted and how to patch into the conference call.


