Dear Mr. Crihan:

This refers to a telephone inquiry by Kathy Modes of this office with your Radiation Safety Officer, Garry L. Balestracci. Ms. Modes left Mr. Balestracci a voice mail message concerning activities authorized by the above listed NRC license. From Mr. Balestracci's electronic mail response dated September 29, 2004, we understand that you have never possessed material authorized by this license and do not plan to acquire such material in the near future for use in NRC jurisdiction. We further understand that you will notify this office by telephone or in writing prior to acquiring licensed material as required by License Condition 12 of the license. If our understanding is incorrect, please inform us in writing.

You are reminded of License Condition 13 of your license which requires that if you do not use licensed material for 24 months, you must notify the Commission and request termination of your license. Your license was issued on January 6, 2003. Twenty-four months from the date of issuance will be January 6, 2005. By January 6, 2005, please respond to this letter in writing and describe your plans to comply with this requirement. NRC Form 314 (copy enclosed) should be used to request termination of your license.

Mr. Balestracci indicated that you may wish to perform radiography in another country. 10 CFR Part 110 (copy enclosed) provides guidance regarding import and export of nuclear equipment and material.

In accordance with 10 CFR 2.390, a copy of this letter will be placed in the NRC Public Document Room and will be accessible from the NRC Web site at <http://www.nrc.gov/reading-rm.html>.
