Requests for Additional Information on Foreign Ownership, Control, or Influence

1. Foreign Ownership, Control, or Influence (FOCI) certification.

Provide FOCI certifications from the general partners using certifications from appropriate employees of those firms.

Under 10 CFR 95.15(b), an applicant for a facility clearance must provide FOCI information.

Mr. Ferland from Louisiana Energy Services (LES) certified FOCI Form SF 328. Since he is not affiliated with one of the general partners, individuals from Urenco Investments, Inc. and Westinghouse Enrichment Company LLC, must certify the applicable SF 328s. Only the general partners of a limited partnership may execute the FOCI certification.

2. Owners, Officers, Directors, and Executive Personnel (OODEPs) Form

Provide full information on the OODEPs Form.

Under 10 CFR 95.15(b), an applicant for a facility clearance must provide FOCI information.

The OODEPs Form must list the general partners (e.g., Urenco Inc.) and their percentage of ownership. Then it must list the limited partners and their percentage of ownership. Lastly, it must list the management committee members separately and any percentage of ownership they may have. Also, please list a telephone number for LES on the OODEPs Form.

3. Certificate of Limited Partnership

Provide a copy of the Certificate of Limited Partnership for LES.

Under 10 CFR 95.15(b), an applicant for a facility clearance must provide FOCI information.

LES stated in its submittal that it is incorporated in Delaware. LES needs to provide a copy of its Certificate of Limited Partnership with its FOCI submittal.

4. Financial Information

Provide the latest consolidated Annual Report or Audited Financial Information, including notes, for the most recently closed accounting year.

Under 10 CFR 95.15(b), an applicant for a facility clearance must provide FOCI information.

LES must submit its latest consolidated Annual Report or Audited Financial Information, including notes, for the most recently closed accounting year. (If audit report is not available, LES must certify to the unavailability of the audited information requested).

5. FOCI Packages for Urenco Investments, Inc., and Westinghouse Enrichment Company, LLC

Provide separate and complete FOCI packages for Urenco Investments, Inc., and Westinghouse Enrichment Company, LLC.

Under 10 CFR 95.15(b), an applicant for a facility clearance must provide FOCI information.

To complete the review of the FOCI information, separate and complete FOCI packages for Urenco Investments, Inc., and Westinghouse Enrichment Company, LLC are needed.
