The Nuclear Regulatory Commission issued Order EA-03-039, *Compensatory Measures Related to Training Enhancements on Tactical and Firearms Proficiency and Physical Fitness Applicable to Armed Nuclear Power Plant Security Force Personnel*, ("Order") on April 29, 2003, for NRC Docket Nos. 50-269, 50-270, 50-287, Oconee Nuclear Station, NRC Docket Nos. 50-369, 50-370, McGuire Nuclear Station, and NRC Docket Nos. 50-413, 50-414, Catawba Nuclear Station. Section III.A.2. of the Order required that Oconee, McGuire, and Catawba Nuclear Stations complete implementation of the requirements in Attachment 2 to the Order by October 29, 2004. Section III.C.2. of the Order required that Oconee, McGuire, and Catawba Nuclear Stations report to the Commission when they have achieved full compliance with the requirements described in Attachment 2 to the Order.

In accordance with 10 C.F.R. §50.4 and pursuant to Section III.C.2. of the Order, Duke Energy Corporation ("Duke") hereby reports it has achieved full compliance with the Order for NRC Docket Nos. 50-269, 50-270, 50-287, Oconee Nuclear Station, NRC Docket Nos. 50-369, 50-370, McGuire Nuclear Station, and NRC Docket Nos. 50-413, 50-414, Catawba Nuclear Station.

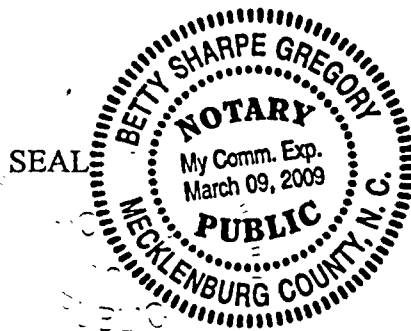
