- **Significant Upcoming Activities:**
 - **Confirmatory Order Independent Assessments**
 - **Mid-Cycle Outage in the Winter of 2005 to inspect the Vessel Head and Under Vessel Area**
- **Operating Safely with Increased NRC Inspection and Management Oversight**



NRC Assessment of Perry

- **Perry is currently in Action Matrix Column 4**
- **Significant Upcoming Activities:**
 - **Implementation of Improvement Initiative**
 - **Refueling Outage in the Winter of 2005**
 - **Inspection Procedure 95003 in Spring of 2005**
- **Operating Safely with Increased NRC Inspection and Management Oversight**
