

The purpose of this modification is to: (1) exercise Option Period Two of the subject contract; (2) provide funding in the amount of \$150,000.00 for performance of work under Option Period Two; and (3) extend the period of performance from December 1, 2003 to November 30, 2005.

Accordingly, the contract is modified as follows:

1. Option Period Two, is hereby exercised. As a result, the obligated amount of the subject contract is hereby increased by \$150,000.00 from \$138,250.00 to \$288,250.00.

2. Under Contract Clause C.3, "DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MARCH 1987)" the first sentence is hereby deleted in its entirety and replaced with the following:

"The contract shall commence on December 1, 2003 and will expire on November 30, 2005."

3. Under Section B.1 "CONSIDERATION AND OBLIGATION--DELIVERY ORDERS (JUN 1988)" first sentence in paragraph (a) and (b)" are revised to read as follows:

"(a) The total estimated amount of this contract (ceiling) for the products/services order, delivered, and accepted under this contract is \$293,087.50."

"(b) The amount presently obligated with respect to this contract is \$288,250.00."

All other terms and conditions remain unchanged.

As summary of obligations for this contract from the date of award through the date of this action is provided below:

TOTAL 05 OBLIGATIONS AMOUNT:	\$150,000.00
