

The purpose of this modification is to increase the amount funded in the delivery order by \$41,000, from \$244,500 to \$285,500. In addition, Deputy Project Officers are added to the contract in Section 13. Accordingly, the order is hereby modified:

Section 15, Consideration and Obligation - Delivery Orders (JUN 1988), second paragraph, first sentence, is deleted in its entirety and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this order is \$285,500."

Section 13, Project Officer, is revised to add the names of Deputy Project Officers after the Project Officer information as shown below:

"In the event that Mr. Welkie is unavailable, the following individuals may act in his place as Deputy Project Officers: Margie A. Janney (301-415-7245), Leroy A. Hardin (301-415-3130) and Matthew R. Schmit (301-415-7469)."

The following is a summary of obligations, from the date of award through the date of this action:

FY2004 Obligations: \$ 84,500
FY2005 Obligations: 201,000

Cumulative Total of NRC Obligations: \$285,500

This modification obligates FY 05 funds in the amount of \$41,000.

All other terms and conditions of the subject contract, including the ceiling amount of \$2,393,960.40, remain unchanged.
