The purpose of this modification is to increase the amount funded in the delivery order by \$80,000, from \$164,500 to \$244,500. Accordingly, the order is hereby modified:

Section 15, Consideration and Obligation - Delivery Orders (JUN 1988), second paragraph, first sentence, is deleted in its entirety and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this order is \$164,500."

This modification obligates FY 05 funds in the amount of \$80,000.
