

The purpose of this modification is to: 1) Incorporate a within scope change to the order to add a new subtask in accordance with the attached statement of work; 2) Increase the BPA order ceiling amount by \$17,656.00, from \$157,766.08 to \$175,422.08, and 3) Confirm verbal authorization, provided by Carolyn Cooper, of my staff, to extend the period of performance of the order through September 30, 2006. Accordingly, the order is hereby modified:

1) Statement of Work, Task 2, is modified to add the following:

"Task 2b.

The contractor shall develop and implement an audit process for performing an audit of central configuration management (CM) for NRC applications using ERS where an independent contractor is performing maintenance activities on the software under center CM control. The audit process shall ensure the RUP is being utilized."

2) Optional Form 347, Block 17. Schedule, second paragraph, first sentence, beginning with "The total estimated . . . " is deleted and substituted with the following in lieu thereof:

"The total estimated ceiling amount of this order is \$175,422.08."

3) Optional Form 347, Block 17. Schedule, third paragraph beginning with "The period of performance . . . " is deleted and substituted with the following in lieu thereof:

"The period of performance of this order is October 1, 2003 through September 30, 2006"

This modification obligates no funds.
