On June 17, 2004, Judith A. Joustra of this office conducted an inspection at the above address. The inspection was limited to a review of your implementation of the Compensatory Measures associated with the Security Order issued on June 6, 2003. The findings of the inspection were discussed with you and members of your staff at the conclusion of the inspection. The enclosed inspection record presents the results of this inspection.

The inspection examined activities conducted under your license as they relate to common defense and security, and to compliance with the Commission's Order. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel.

The inspection record enclosed herewith contains Safeguards Information - Modified Handling, whose protection is delineated in the June 6, 2003 Order, and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material will not be placed in the Public Document Room.
