Dear Mr. Gresham:

On May 12, 2003, Westinghouse Electric Company (Westinghouse) submitted WCAP-16081-P, "10x10 SVEA Fuel Critical Power Experiments and CPR Correlation: SVEA-96 Optima2," to the staff for review. Enclosed for Westinghouse's review and comment is a copy of the staff's draft safety evaluation (SE) for the TR.

Pursuant to 10 CFR 2.390, we have determined that the SE provided as Enclosure 1 contains proprietary information. Proprietary information contained in Enclosure 1 is indicated in **bold**. We have prepared a non-proprietary version of the SE (Enclosure 2). However, we will delay placing Enclosure 2 in the public document room for a period of ten working days from the date of this letter to provide you with the opportunity to comment on the proprietary aspects. If you believe that any information in Enclosure 2 is proprietary, please identify such information line-by-line and define the basis pursuant to the criteria of 10 CFR 2.390. After ten working days, Enclosure 2 will be made publicly available, and an additional ten working days are provided to you to comment on any factual errors or clarity concerns contained in the SE. The final SE (proprietary and non-proprietary) will be issued after making any necessary changes. The non-proprietary SE will be made publicly available. The staff's disposition of your comments on the draft SE will be discussed in the final SE.

To facilitate the staff's review of your comments, please provide a marked-up copy of the draft SE showing proposed changes and provide a summary table of the proposed changes.

Enclosure 1 transmitted herewith contains sensitive unclassified information. When separated from Enclosure 1, this document is decontrolled.
