- a) Your new Radiation Safety Officer, Steven R. Whitmoyer, M.D., is listed as an Authorized User for only two of the uses on your license. Please assure that he receives training in the radiation safety aspects of procedures permitted by 10 CFR 35.300 and 35.400.
- b) Future license amendment requests should be signed by a member of senior management.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please note that on October 25, 2004, the NRC suspended public access to ADAMS, and initiated an additional security review of publicly available documents to ensure that potentially sensitive information is removed from the ADAMS database accessible through the NRC's web site.
