This refers to your license amendment request dated October 7, 2004. Enclosed with this letter is the amended license adding three individuals as authorized users. However, you did not provide adequate information on the preceptor statement to add a fourth individual, Dr. John Rogers, as an authorized user. As discussed in a telephone conversation on January 6, 2005, between Mr. Robert Glossner, of your staff, and Mr. Joseph Nick, of the NRC, the information submitted for Dr. Rogers did not contain a detailed description of his prior work experience in accordance with 10 CFR Parts 35.940 and 35.960. If you still wish to add Dr. Rogers as an authorized user, please submit the complete required information in a new amendment request. In addition, please note that many of the license conditions were revised to the current NRC format.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

*An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).*

Please note that on October 25, 2004, the NRC suspended public access to ADAMS, and initiated an additional security review of publicly available documents to ensure that potentially sensitive information is removed from the ADAMS database accessible through the NRC's web site.
